## TOURNAMENT ELIGIBILITY REQUIREMENTS

This tournament is certified by the United States Bowling Congress and any USBC rule not specifically stated, waived or modified in these rules will apply where applicable. Download this form at [www.kingpinsalley.com](http://www.kingpinsalley.com)

**1. Competition**—*Lanes will be stripped and oiled before every squad*

- Competition will consist of five player teams
- WALK-INS WILL BE ACCEPTED ONLY IF LANES ARE AVAILABLE.
- Lanes will be assigned by the tournament director
- BOWLERS WITH AVERAGES OF 220 OR HIGHER CAN COMPETE IN SCRATCH BRACKETS ONLY.

**2. Entrants**

The Kingpin's Alley Team Tournament is open to all members in good standing of the USBC, NYS USBC and a local NYS USBC association and are conducted under USBC rules and regulations. Non-Members of the NYS USBC residing in New York State can become eligible by purchasing a USBC membership card for \$20. Unmarried students under the age of 18 must have parental consent. Special needs persons must report in writing when entry is submitted. No re-arranging of bowlers once entry is processed. Substitutes will be allowed as long as they meet tournament requirements.

**3. Multiple Participation**

Multiple participation will be allowed. In order to place more than once in the prize list a team must change at least two players in the lineup.

**4. Averages**

Entrants shall use their HIGHEST USBC certified average over the past 2 seasons as a regular or substitute bowler in the following order:

1. Official average for the past season (2017-18) for 21 games or more.
2. Official average for the 2016-17 season for 21 games or more.
3. A bowler without a verifiable average will bowl scratch. PLEASE NOTE THAT USBC RULE 319a-3 WILL APPLY.
4. Sport League averages must be submitted on the entry form and noted as "Sport".
5. Any averages not available on bowl.com must have a league standing sheet or signed verification by local association manager.

**5. Handicap**

Handicap will be determined using a TEAM HANDICAP METHOD, and will be based on 90 percent of the difference in the cumulative averages and 1100. Those teams over 1100 will bowl scratch. Team handicap will be computed by adding the individual averages of the bowlers Entered, and taking 90 percent of the difference in that total and 1100.

**6. Entry Fees**

Entry fee is \$250 per team and must be paid in full prior to competition. Prize money will be awarded 100% with a ratio of 1:6. All prizes will be awarded based on handicap scores. There will be no scratch prizes awarded. In the event of a tie for any prize position, the prize will be split between the two positions.

**7. Bonus money\***

All of the record scores listed on the front of this form are scratch scores. The bonus money listed for breaking any of these records will be paid based strictly on SCRATCH SCORES. All scores are subject to USBC approval. In the event that a team breaks multiple records they may only take the HIGHEST CASH AWARD. No team may win multiple prizes. Should more than one team break any one record, the team with the highest score will be awarded the prize money.

**8. Disclosure**

Entrants whose names appear here or their authorized replacements hereby agree that the Kingpin's Alley Family Fun Center, LLC, its officer and agents shall be liable only to the extent of returning the prize portion and bowling fees of an entry if and when these entrants shall be prevented from bowling in this tournament through premature termination of the event which may be brought about by war, national emergency or emergencies from fires, strikes, lockouts, labor difficulties or other causes beyond the control of Kingpin's Alley Family Fun Center, LLC.
